# दुग्ध उत्पादकों को मिलेगा प्रति लीटर दूध पर ५ रुपए का बोनस

### मोहन सरकार की तैयारी

भोपाल,(निप्र)। प्रदेश में दुग्ध उत्पादन को बढावा देने के लिए सरकार दुग्ध उत्पादकों को पांच रुपये प्रति लीटर प्रोत्साहन राशि देगी। यह राशि दग्ध सहकारी समितियों से जुड़े दुग्ध उत्पादकों को दी जाएगी। इसी माह कैबिनेट की बैठक में इसका प्रस्ताव लाने की तैयारी है। किसानों को मिल रही प्रोत्साहन राशि

झारखंड, राजस्थान, महाराष्ट्र और असम में पहले से किसानों को पांच रुपये प्रति माह प्रोत्साहन राशि दी जा रही है। हालांकि, सरकार की इस योजना से प्रदेश के लगभग 15 प्रतिशत दुग्ध उत्पादकों को ही लाभ मिल पाएगा। कारण, इतने ही किसान दुग्ध उत्पादक सहकारी समितियों से जुड़े हैं।

### छह सहकारी द्ग्ध संघों में पहुंचता है

पशुपालन विभाग के अधिकारियों ने बताया कि दुग्ध उत्पादक सहकारी समितियों के माध्यम से प्रतिदिन 10 लाख लीटर दुध संग्रहीत किया जाता है, जिस पर सहायता दी जाएगी। यही दुध प्रदेश के छह सहकारी दुग्ध संघों में पहुंचता है जहां से



बिक्री के लिए भेजा जाता है।

### सीएम मोहन ने देखा था अमूल मॉडल

दरअसल, राज्य सरकार वर्तमान वर्ष को गोरक्षा वर्ष के रूप में मना रही है। इसी कड़ी में गोपालकों के लिए यह सहायता राशि देने का निर्णय लिया गया है। प्रदेश में दुध का उत्पादन बढाने के लिए मुख्यमंत्री डॉ. मोहन यादव ने इसी वर्ष जनवरी में अहमदाबाद में अमुल का मॉडल देखा था। इसके अनुरूप उत्पादन बढाने पर जोर है। पशुपालन विभाग के प्रमुख सचिव गुलशन बामरा ने बताया कि किसानों को सहायता देने में प्रतिवर्ष लगभग दो सौ करोड़ रुपये का खर्च आएगा। एक से दो माह में कैबिनेट के लिए प्रस्ताव भेजा जाएगा।

भारी बारिश के अलर्ट होने से राजधानी भोपाल में रातभर पानी गिरा। इस कारण कई इलाकों में जलभराव भी हो गया। पराने शहर के छोला समेत अन्य इलाकों में एक फीट तक पानी जमा रहा। रात में ही भोपाल में ढाई इंच पानी गिर गया। अगस्त के लगातार चौथे दिन रविवार सुबह से बारिश का दौर जारी है। कोलार स्थित भूमिका रेसीडेंसी के गेट के पास की नदी किनारे की मिट्टी ढह गई। वहीं गेट पर दरारें आ गई। इसके चलते लोगों को अलर्ट किया है। मौसम विभाग ने भारी बारिश होने का अलर्ट जारी किया है। इस बीच, भोपाल के भदभदा के 2 गेट रविवार को फिर से खोलने पड़े। इन गेट से पानी का इतना अधिक प्रेशर रहा कि किलयासोत डैम के 11 गेट खोलने पड़े। ये गेट आधे-आधे खुले है। इस वजह से किलयासोत नदी में भी पानी तेजी से पहुंच रहा है। दामखेडा और समरधा टोला के लोगों को अलर्ट किया है।

### भोपाल में अब तक 30 इंच बारिश

भोपाल में अब तक 30 इंच से ज्यादा बारिश हो चुकी है, जो सीजन की 80 प्रतिशत तक है। इस वजह से भोपाल के सभी जल स्त्रोतों में पानी आ गया है। बडा तालाब अपने फुल टैंक लेवल 1666.80 फीट तक पहुंच गया। इसके बाद भदभदा और कलियासोत डैम के गेट खोल दिए गए। अगस्त के महीने में भोपाल में एवरेज 14 दिन बारिश होने का ट्रेंड है। इस महीने 13 इंच पानी बरसता है। इस बार शुरूआत के 3 दिन में 4 इंच से ज्यादा पानी गिर चुका है। इससे शनिवार तक आंकडा 30 इंच के पार हो गया।
