#### Strikes on Gaza US, China hold first nuclear talks in 5 yrs Strip, Rafah

Israeli forces pounded Rafah and other areas across the Gaza Strip and engaged in close-quarter combat with fighters led by Palestinian Islamist group Hamas, residents and Israel's military said.

Residents said the Israelis appeared to be trying to complete their capture of Rafah; the city has been the focus of an Israeli assault since Mav. Tanks were forcing their way into the western and northern parts of the city, having already captured the east, south and centre. Israeli forces fired from planes, tanks and ships off the coast, forcing a new wave of displacement from the city, which had been sheltering more than a million displaced people, most of whom have been forced to flee again. The Israeli military said on Friday its forces were conducting "precise, intelligencebased" actions in the Rafah area, where troops were involved in close-quarter combat and had located tunnels used by militants.
